WHEREAS, Article XIII, Section 13-12, of the Hawai'i County Charter provides that the Council, on behalf of the County, may accept gifts of donations of money, securities or other personal property or of real estate or any interest in real estate, and Chapter 2, Article 30, Section 2-162(a) of the Hawai'i County Code states that any gifts or donations of money, securities, or personal property which fall within the capitalization procedures of the Department of Finance, may be accepted by Resolution approved by the Council; and

WHEREAS, the Office of the County Clerk recommends the acceptance of this grant award; now, therefore,

BE IT RESOLVED BY THE COUNCIL OF THE COUNTY OF HAWAI'I

that in accordance with Article XIII, Section 13-12, of the Hawai'i County Charter, and Chapter 2, Article 30, Section 2-162(a) of the Hawai'i County Code, the Council of the County of Hawai'i accepts this grant award.
