Pursuant to Hawaii Administrative Rules (HAR), Section 13-168-7(b), "The owner or operator of any well or stream diversion works or battery of such water sources shall file a report of total water usage on a regular monthly (calendar or work schedule) basis to the commission on forms provided by the commission on or before the end of the month following the month for which water usage is to be reported. The reports may include other use-related information such as type of use, salinity, and water level, as may be deemed appropriate and reasonable by the commission."

Current Status and Stream Diversion Modifications

According to our records and based on prior communications with Mr. Bill Shontell of Surety Kohala Corporation, which previously managed Kohala Ditch, it is our understanding that these diversions are currently inactive. However, there may continue to be incidental diversion of water from these intakes to Kohala Ditch. Please provide an update on the current status of these diversions and any current or future plans for their continued use.

Should you intend to modify any of the stream diversions, please be aware that pursuant to HAR Section 13-168-32, "No person shall construct or alter a stream diversion works, other than in the course of normal maintenance, without first obtaining a stream diversion permit from the commission. The commission may impose such reasonable conditions as are necessary to assure that the construction or alteration of such stream diversion works will not be inconsistent with the general plan and land use policies of the state and the affected county."
