There's no litigation yet.

The macro picture is that when the community was trying to raise funding for the ditch after the collapse, it was roundly dismissed by public officials as a no-go, because of the complicated private ownership of parts of the ditch.

On a more micro level, after the ditch got knocked out, this transaction took place not too long after. The landowner was in talks to build a pipeline to bring water to others, but the source of water to be utilized was never disclosed or figured out, and there was no permit for this pipeline with CWRM. During a local meeting the landowner said he was putting in the pipeline, but could not promise to run the water off his property. It was relayed to me earlier this year, but needs confirming that pipeline plans were abandoned.

Anyway, to tie it back to this, the \$10 million bookmarked for the fix of the ditch, given the details of private landownership being an issue in the past, alongside these more focused details, wonder if there has been any planning to deal with it in case it comes to that.
