Aloha Scott:

Thanks for your email.

I need to keep it in writing. Some incidents are likely to go to litigation.

I am desirous of some police reports. I was directed to call Records. I did, left a message, no one called. Months ago.

An assault and battery of a Caucasian male allegedly by a local male took place Valentines Day 2016 on Pila'a Beach. Gary Stewart and Mark Zuckerberg both own land maula of the beach. The victim said it was a hate crime as he was called a "f..haole" multiple times. He stated he filed a complaint with KPD and report 2016-01963 was generated. Two months after the incident the victim was told the report was pending. I would like a copy and the name of the investigating officer.

A second incident I am seeking a report for is detailed in the January 25, 2017 Honolulu Star Advertiser. I also want the name of the officer who investigated. Naoshi Grady alleged a group of hostile males told him to leave Waipake Beach where he was fishing. I do not have a date or report number. Mark Zuckerberg owns the land mauka of that Beach.

A third incident took place September 3, 2017 on Larsen's Beach at Lepeuli. Tenant of Waioli Corporation (Wilcox) Bruce Laymon marched along the beach with a gang of males engaging in shouting matches with members of the public. Lamon violated my privacy and harassex me, and several other beach goers. I emailed a complaint to Chief Perry and the

Prosecuting Attorney. Someone called KPD to complain. Sarah Blane stated to me report 2017-18535 was created. I want a copy of that report and the name if the officer who investigated.

On September 4, 2017 two officers from KPD were called by an unknown complainant to Larsen's Beach. I would like a copy of that report, and the names of the two officers.

As mentioned, records was non-responsive to me. This being 2017, your agency needs to process reports electronically as do other county and state agencies. Thank you.
