Myself and my colleague, Dominic, provide technical support for EC meetings which includes facilitating the Zoom testifiers. Over the course of the meeting, there were two incidents of participants inappropriately exposing themselves and performing sexual acts. In both cases, we were able to stop and report their videos within seconds. We believe that the report function in Zoom automatically ejected the participants from the meeting. I have attached copies of our reports to Zoom for your reference.

With that said, this opens the conversation of whether we should continue to allow all Zoom participants to share their video throughout the entire duration of the meeting. We have the capability of disabling video for participants, similar to how currently audio is disabled for all participants. It is only when someone has raised their hand to testify that we allow them to share their audio. The same can be done for video.

Please let us know your thoughts and how you wish to proceed for future meetings.

I am writing to request an immediate federal investigation into the actions of Shelby Jason Brown, a known affiliate of the Hawaiian Kingdom movement, and the broader coordinated efforts by this group to interfere with Hawaii's elections. Mr. Brown has personally targeted me with threats, harassment, and doxing, while this movement has engaged in broader activities that I believe constitute domestic terrorism and election interference.

The Hawaii Election Commission's stated mission is "to provide secure, accessible, and convenient election services to all citizens statewide." However, the coordinated actions of Shelby Jason Brown and the Hawaiian Kingdom movement threaten this mission and the very

foundation of free and fair elections in Hawaii.

---

Shelby Jason Brown: Targeted Harassment and Threats Against Me

During the December 18, 2024, Hawaii Election Commission meeting, I provided testimony exposing election interference linked to the Hawaiian Kingdom movement. Following my testimony, Mr. Brown verbally attacked me, publicly doxed my personal and financial information, and incited others to harass me. Since then, he has escalated his campaign of intimidation, including:

Death Threats: Explicitly calling for harm to me, both physically and emotionally, on social media platforms.

Doxing: Sharing my personal and financial information publicly, leading to targeted harassment and threats against me.

Intimidation: Coordinating online harassment campaigns, threatening my livelihood, and creating an unsafe environment for me to exercise my First Amendment rights.

These actions are not isolated but part of a broader pattern of behavior by individuals affiliated with the Hawaiian Kingdom movement, which seeks to undermine Hawaii's electoral process.

Organized Election Interference by the Hawaiian Kingdom Movement

Shelby Jason Brown's threats are part of a larger effort by the Hawaiian Kingdom movement to destabilize Hawaii's democracy and electoral integrity. Key activities include:

1. Foreign Influence and Fundraising: Members of this movement have fundraised for a foreign national from Greece, known as "Dakine

Residenalienhi," who has publicly advocated for the overthrow of Hawaii's political system. Evidence shows fundraising efforts were coordinated by members of the Hawaii Republican Party, including *funds* received by Sharron VanDeusen and Always Aloha aka Josh Gandy Both Chairs in the Republican Party.

who organized fundraisers to raise money for this individual's citizenship, so he could run for office and represent Hawaii despite legal prohibitions against foreign influence in U.S. elections.





Da Kine (@residentalienhi), a Twitter user who infiltrated pro-Trump circles in Hawaii, advocating for Hawaiian sovereignty through the GOP. In a since-deleted tweet captured by HIRA, Da Kine suggested using the Hawaii GOP as a tool to achieve sovereignty and restore an independent Hawaiian kingdom. Though he later claimed the tweet was misunderstood, his participation in a Twitter Space with Joshua Gandy (@alohacode) discussing these very topics—and his appearance under the alias "Phil Smith" on Wendy Bell's show—only deepened suspicions.

2. Coordination with Election Commissioners: Individuals linked to this movement, may have worked closely with a few Kingdom election commissioners to manipulate processes and undermine Hawaii's elections. Shelby Jason Brown aliases Shelby Billionaire Pikachu, Ralph

3. Strategic Infiltration: Members of this movement have sought to gain seats within political parties and influence election processes to advance their agenda of reinstating the Hawaiian Kingdom, which they falsely claim still exists as a sovereign entity.

In addition to Shelby Jason Brown, several other individuals may have played a significant role in these efforts, and further investigation is warranted.

### Request for Federal Action

The coordinated actions of Shelby Jason Brown and the Hawaiian Kingdom movement pose a significant threat to Hawaii's electoral integrity and public safety. I respectfully request the following actions:

- 1. Investigate Shelby Jason Brown: Examine his threats, harassment, and doxing as acts of domestic terrorism and election interference.
- 2. Investigate the Hawaiian Kingdom Movement: Conduct a thorough inquiry into the group's activities, including their foreign influence, coordination with election officials, and broader efforts to undermine Hawaii's democracy.

- 3. Protect Threatened Individuals: Provide safeguards for those of us who have been targeted by this movement's intimidation tactics.
- 4. Enforce Accountability: Prosecute those responsible for violating federal election laws and threatening public safety.



The Hawaii Office of Elections is tasked with providing secure, accessible, and fair election services. The actions of Shelby Jason Brown, the Hawaiian Kingdom movement, and their affiliates directly undermine this mission and the democratic principles of the United States. Their coordinated efforts to intimidate and manipulate Hawaii's electoral system must be addressed immediately to protect the integrity of our elections and ensure the safety of all citizens.

I have compiled extensive evidence, including screenshots, videos, and documentation of threats, doxing, and fundraising activities, which I am prepared to share as part of this investigation.


