Dear Mr. Sakata:

Pursuant to direction received from Karley Halsted, with the HDOT Rail Coordination Team (AGS) on September 25, 2017 (pg 39 of 55), and October 11, 2017 (pg 53 of 55) STGJV (Shimmick/Traylor/Granite Joint Venture) must deliver to HDOT a revocable permit request for use of the areas defined within the HART easement and potential TCE's described below and attached documents. As a first step as defined in the attached Revocable Permit Process (page 1 in the Revocable Permit Issue Packet) STG JV hereby sends this letter requesting use of the following parcels.

**Revocable Permit Process Section 2.**

As part of the Revocable Permit Process the following documents are to be provided after a response is received from HDOT Airport. To expedite the process STGJV hereby provides the following:

- A. Draft Copy of the Tax Clearance Application (Currently being updated, however a draft is attached herein)
- B. Insurance Requirements – STG has provided HDOT insurance information with other submittals and will provide with the final application.
- C. Certificate of Good Standing from the State of Hawaii Department of Commerce and Consumer Affairs (second attachment herein)
- D. Remittance amount to be determined. Please note the land use is for the construction of the City of Honolulu Rail System.


The parcels requested above do not have existing tenants occupying the parcel. The space is needed to construct the HART Rail System. As directed by the HDOT Rail Coordination Team STGJV must follow this process, however takes exception to not being allowed use of the areas shown as HART easements. STGJV has notified HART that this process is being pursued under protest, however hopes to expedite the process with HDOT Airport.
